As of 12/27/2024 the department is knocking on the door of 75%. Membership Goal of 80% is just 2 weeks away, January 15th. With the holidays in the rear view mirror, we need to get on our renewals. And speaking of retention rate! **REMEMBER**, the retention contest has a crucial deadline looming. A Post must achieve a 95% retention rate to remain eligible to remain in the running for a \$500.00 retention prize. Get 100% by New Years Eve - earn an additional 5 pts.

5 of 9 Districts made it to the 75% goal, but we are short of the 80% by a fairly wide margin. Let's look under every stone and carpet for renewals and new members. Why harp on membership continuously? We are a member based organization, and members drive the programs and the votes. And the votes drive Congress to back veteran programs

Can't say this enough: Got your permissions to work membership on MyLegion.org? If not, let us know, we can help. Before you call, make sure the Post Commander and Adjutant form is current. 29% have not submitted this form.

462 Post: This is our "cloud" of members, most know what it is and how it works. I will be sending this list out, want to get on an exclusive e-mail list, send me a note. Prepared as an Excel spread-sheet, it will be distributed to your District Membership Team (DMT).

Membership Sources: Everywhere. Headed to a veteran centric event, bring along a couple of "Why Belong" brochures, spread the good word of The American Legion.

2025 Membership Retention Contest

Discussion: To effectually sustain growth, current members need to renew their memberships. Providing incentives and goals as targets with a financial reward has proven to be an effective means. DMS/Holding Post 462 and the Capitol Hill Post 297 are not eligible for this program.

Eligibility: The District must have a Membership Team appointed.

Post must physically meet a minimum of 4 times per year.

Post must attain a 95% renewal/retention rate.

Post must submit "Post Data Report" by April 15th of the Contest Year.

Post must submit "Consolidated Post Report" by May 31st of Contest Year.

Post must submit "Post Roster" by May 31st of Contest Year.

Post must submit "Certification of Service Record" by May 31st of Contest Year.

Post Membership designee must be registered in MyLegion.org.

Bonus point considerations: 1/2 point for each percentage point over 95%

Commander and Adjutants Report - 2 pts 100% Retention by 31 December - 5 pts

Given recent changes in the Scouting program, now known as **Scouting America**, as well as the confusion between eligibility requirements for the **TAL Eagle Scout of the Year** versus the eligibility for the TAL Department Camporee, please follow these guidelines as listed on The American Legion National site, and The Dept of Massachusetts:

Applications must be received by 17MAR25

- via e-mail to: oc1776@gmiail.com, Scouting Chair, OC OConnor

Eligibility Requirements:

https://www.legion.org/get-involved/scholarships/american-legion-eagle-scoutof-the-year-scholarship

THE NOMINEE MUST:

• Be either a registered active member of a Boy Scouts of America unit that is **CHARTERED** to an American Legion post, American Legion Auxiliary unit or Sons of The American Legion squadron. A Scouting unit that is solely "sponsored' to attend the annual Department of Massachusetts, American Legion Camporee does not qualify for this CHARTERING status.

OR

• Be a registered active member of any chartered Boy Scouts of America unit and have a parent or grandparent possessing up-to-date membership in The American Legion or Sons of The American Legion or American Legion Auxiliary, and in the case of a recently deceased member, their membership for the year immediately prior to the current year may be used.

AND

- Received the Eagle Scout Award.
- Received a Scouts BSA or Venturer Religious Emblem.
- Have demonstrated practical citizenship in church, school, Scouting and community.
- Have reached their 15th birthday and be enrolled in high school at the time of selection.
- Applied through the department (state) in which their Scout unit is chartered.
- Provide documentation of current BSA membership. (Membership must be valid for the year in which you are applying.)

The 2025 Boys State Program will be held at Stonehill College, North Easton, from Saturday, June 14, 2025 to Friday, June 20, 2025 This year, the cost of sponsoring each boy will be \$\frac{\$400.00}{000}\$ for the regular tuition, or \$\frac{\$375.00}{000}\$ for those who pay for students by the "EARLY BIRD" registration date of APRIL 15, 2025, after the cost is \$400.00. Please make your check payable to "The American Legion" and designate "Boys State" in the lower left corner of the check. Please use the tear-off sheet at the bottom of this notice (page 2) indicating your Post Chairman, as all future correspondence will be mailed directly to them. All checks for the 2025 Boys State Session must be in the hands of chairman by May 20, 2025. The first 400 applications will be accepted. We encourage you to actively seek outside co-sponsors (e.g. politicians, businesses, or banks) to help pay for these boys to attend.

Boys chosen to attend Boys State must be interviewed by the Post Chairman, and his signature attesting to this must appear on Citizen Applications. Each Post Chairman should explain Boys State in detail to the boys and their parents so that they will know what is expected of them during their stay. The Boys State website (http://www.maboysstate.org/) contains a wealth of information, 2025 interest application, including video, photographs, program books, and program descriptions. Students and parents should be directed to this resource for information and announcements.

Beginning in January 2025, we will have applications available via email or regular mail. Please select the email option on the tear-off sheet if that is how you would like to receive the paperwork.

How to Recognize and Avoid Phishing Scams

Many of you have been receiving E-mails claiming to be from officers of the Department including the Commander. Scammers use email or text messages to trick you into giving them your personal and financial information. But there are several ways to protect yourself.

How To Recognize Phishing

Scammers use email or text messages to try to steal your passwords, account numbers, or Social Security numbers. If they get that information, they could get access to your email, bank, or other accounts. Or they could sell your information to other scammers. Scammers launch thousands of phishing attacks like these every day — and they're often successful.

Scammers often update their tactics to keep up with the latest news or trends, but here are some common tactics used in phishing emails or text messages:

Phishing emails and text messages often tell a story to trick you into clicking on a link or opening an attachment. You might get an unexpected email or text message that looks like it's from a company you know or trust, like a bank or a credit card or utility company. Or maybe it's from an online payment website or app. The message could be from a scammer, who might:

say they've noticed some suspicious activity or log-in attempts — they haven't Impersonate someone you know, like a family member, friend, or coworker. — it's fake claim there's a problem with your account or your payment information — there isn't say you need to confirm some personal or financial information — you don't include an invoice you don't recognize — it's fake want you to click on a link to make a payment — but the link has malware say you're eligible to register for a government refund — it's a scam offer a coupon for free stuff — it's not real claim they are busy and need you to buy something for them — it's not real

Imagine you saw this in your inbox. At first glance, this email looks real, but it's not. Scammers who send emails like this one are hoping you won't notice it's a fake.

Here are signs that this email is a scam, even though it looks like it comes from a company you know — and even uses the Departments information and Officer titles:

The email has a generic greeting, (she has never called me Andrew)

The return email is not the email the person uses. (presidentplace@sapo.pt)

The email Says communication by phone is not available. (This is done so you will not check)

The email invites you to click on a link or asks for a payment be made of any kind.

While real companies might communicate with you by email, legitimate companies won't email or text with a link to update your payment information. None of the Officers will email you asking for gift cards or any other items. Phishing emails can often have real consequences for people who give scammers their information, including identity theft. And they might harm the reputation of the companies they're spoofing.

Hope this helps all of you in understanding and helping others know what to look for.

With the beginning of a New Year, most of us make a pledge to do something positive Here are 2 suggestions for all Legion members.

Basic Training:

The American Legion's official training program for officers, members, Legion College applicants and those who simply want to expand their knowledge of the nation's largest veterans service organization is now available online.

Already taken the old course? The American Legion Extension Institute has been rewritten, updated, streamlined and enhanced with videos, digital photos, clickable links, a historical timeline and additional features. The program should take less than two hours to complete. It is divided into six sections, with a quiz at the end of each one, followed by a final exam.

The course is arranged into 5 major topic areas and 1 concluding section. Each section will present information about the topic via text, images and video.

At the end of each topic area there is a quiz that will help gauge your understanding of the material. When you've completed each section quiz, you'll be able to take the final exam. The exam will take roughly $^{\sim}30$ minutes to complete.

Having taken the written course back in 2004 and the current course 2 years ago, I can say that is very current. Also, I found it easier to do it online. I encourage all to take the course and learn more about YOUR American Legion.

Although the election cycle is done for now, the legislative cycle begins again in January. This is where you and I continue to be involved. Our Congressional representatives in both the House and Senate need to hear from you AND I on how we want them to vote. The best way is by email and the easiest way is to follow the process outlined next.



- Spell check everything! Especially people's names, web addresses, etc. You can help us greatly here by simply running your spell check function in your word processing program.
- E-mail everything directly to us at fmacdonald53@comcast.net no later than the 25th of every month for it to appear in the very next issue. This way we have plenty of time to work with in case we need to clarify anything with you.
