Treasurer

TRS Souza reported:

Department Treasurer Steve Souza reported the Finance report as of 3/12/2021. He stated the following were hi-lights for this period.

Steve reported that we have an operating budget of \$479,574.00 with anticipated expenses of \$469,478.00. This brings us to a positive balance of \$10,096.00.

The good news; due to the Covid-19 pandemic, our Department budget has not been taxed to the fullest extent, due to the lack of many activities. We are hopeful to a positive year in finance.

Total investments are at \$4,257,418.61. We must keep in mind many of these investments are restricted in nature and should not be thought of as funds that can be accessed for any reason.

Steve reported he was working on the final version of the 2021-2022 budget with input and assistance from Milton (Dept. Adjutant) and Frank McDonald (Finance Committee Chair).

Steve reported, we need to keep a cautious eye on the membership line item as each year we are seeing a decrease in membership. With this decrease, we are seeing a significant drop in revenue. Steve reminded all, this line item is the life blood of our organization.

Checks were sent out recently for refunds for the National commander's banquet (dinner and ads) and should be at your post. Please check your mail, cash them, so we may clear all checks sent out.

Steve reported Post should look into the possibility of obtaining grants from local banks, as additional funds are now available with the newly passage of the "Stimulus Act". Funding may be available for the PPP program.

Reminder that post should inquire through the Massachusetts Department of the State Treasurer's office to see if your post has any unclaimed property (cash) that can be accessed and returned to you. If you run into an issue, you can contact Mike Noonan @ 617-367-9333 x427. Mike is an investigator with the Treasury that will be working with the American Legion. Steve stated he will be placing an article in the e-legionnaire for those post that want to seek out unclaimed revenue. Steve reported he did for his post and has already received the funds.

Steve stated he will report, under unfinished business, the status of the Department's request for unclaimed property with the State treasurer's office.

Now the percentages are much more difficult to attain but keep on the good work you have started. It is now time to switch gears and start working toward a one hundred per cent submittal of the Consolidated Post Report. All posts know the importance of the Consolidated Post Report. The post's information, combined with that of other post's, is when the National Commander and others testify on Capitol Hill on behalf of all veterans. Each post has a story to tell and when we speak collectively our strength is multiplied.

If the post has activities which cannot be adequately covered on the report form, attach written description with pictures and articles.

Although COVID-19 caused a lot of our programs to be cancelled or abridged there were things that each post could have done in support of our four pillars, Veterans and Rehabilitation, National Defense, Children and Youth and Americanism. Kudos to the Department of Ohio for completing more than 90% of Consolidated Post Report's last year.

The buddy check was added to the Consolidated Post Report a few years ago and is a good starting point. Every post should be doing buddy checks, there are 129 items on the Post Report I'm sure you can find a few that you hadn't thought about before.

If your post did not participate in a program listed on the report, or if unable to get the information by the requested date, leave the section blank. If the post only has one program, then that should be the one reported. If you can't get the exact reports or numbers, please make a reasonable guess.

The CPR runs from June 1, 2020 to May 31, 2021, and we already eight months into the year, 2020-2021 The completed Consolidated Post Report is due in the Departments Office by June 15, 2021 and National Office by July 1, 2021. Most posts Know what they have scheduled for May of 2021. Instead of waiting until June 2021 to submit a CPR. Submit it in May. You can also update your CPR and if necessary, put it on the next reporting year.

When using the paper form, send the original and one copy to the Department Headquarters by June 15, 2021 keep the third copy for the post records.

The paper post counts as much the Plymouth Post, each is about 3% of the total. Weather you have a 15 member posts or an 800 member posts they are both worth about 3 percent of the total. That is why, every post counts.

Every post is responsible for submitting a Consolidated Post Report, in fact many of the awards the American Legion gives out, submittal of a Consolidated Post Report is one of the qualifications.

The 2020-2021 Consolidated Post Report is online at mylegion.org and the Department sent copies to each post in the Department.

SCOUTING COMMITTEE

The Scouting Committee had a Zoom Meeting, on Monday, February 15, 2021.

We reviewed The Eagle Scout of the Year Program (ESotY). Clarifications were made regarding candidate eligibility. Even though Boy Scouts of America granted age extensions for both males and females in 2019 to attain Eagle beyond their 18th year, TAL National did not change their standards. This was received from National: *The 2021 "Eagle Scout of the Year" National application still has a requirement for Eagle Scout Candidate to have reached their "Fifteenth Birthday" and be enrolled in High School.at the time of selection.*

The Committee received applications from Massachusetts Eagle Scout candidates for the Department ESotY. Applications were emailed to Committee Chairs to review and vote on 6MAR21. As soon as I receive confirmation from all Districts, we will announce the winner. That winner will be forwarded to National, representing The Department, on or before 1APR21.

Again, I want to thank PNC Jake Comer for straightening out the National Scouting Committee from not lowering the bar regarding the Religious Award in the ESotY process.

The Department AL Camporee annually held over Father's Day Weekend is again in jeopardy due to the pandemic. If you remember, last year PNC Paul Morin, motioned for a one-time gift of \$1,000.00 to cover last year's ESotY Scholarship when last year's Camporee was cancelled. The Camporee represents our largest revenue stream to pay for our ESotY scholarship each year.

As the Commonwealth reopens from the pandemic, restrictions still exist within the camping realm. Maximum group settings outdoors are still "25" people - even though overnight camping has been approved by the Governor. The Trustees of the campgrounds we use have yet to establish their new guidelines. And, BSA still has a "Family Only" tent policy currently – which translates into only family members can occupy the same tent overnight.

The Scouting Committee has set a deadline 1APR21 to "Green Light" or "Red Light" this year's event. Otherwise, there will not be enough time to plan & organize the Camporee properly.

Our Committee voted for me to query the DEC on the possibility of another year of funding the ESotY Scholarship - if we are not able to hold our Camporee again. While I find no pleasure in asking for this, these circumstances greatly curtail our options. FYI – while I'm in the asking mode, one member of our Committee has offered a viable work around for next year. That being that each District allocate \$100 from their budget to go toward this scholarship.

In closing – May the Saints be Praised in remembrance next week when everyone will be Irish – wear the green -and a Happy Saints Patrick Day to All!

Athletics:

Team Registration began on January 1, 2021. There were 135 teams eligible to return but 6 informed me they will not be fielding teams this year. Thereafter I received 10 New Team Applications, (5 Sr. & 5 Jr..) which were all approved at the February 24, 2021 Athletic Committee Meeting, so we currently have 138 teams, (82 Sr. & 56 Jr..).

Plans to hold 2 Sr. Department Tournaments this year are proceeding. The first one will be hosted by Post 294 at Adams Field, Quincy, beginning on July 24, 2021, with the winner advancing to the Region One Tournament which is being hosted by Post 397 at The College of the Holy Cross, Worcester beginning on August 3, 2021. The second Sr. Tournament will begin on August 7, 2021 but the Committee has not decided on a host as yet.

The Jr. Division will only have one Tournament this year and will be hosted by Post 79 at Libby Park, Weymouth beginning on August 7, 2021. The other Region One Chairmen agreed to push the start of the Jr. Region One Tournament back to August 13, 2021 so that we can participate. The Jr. Region One Tournament will be held at Murane Field, Utica, NY.

We continue to await the MIAA finalizing their schedule in order for us to pin down our schedule. As of today it appears the MIAA will begin the baseball season on April 26, 2021 and will hold some type of Sectional Tournament which is scheduled to begin during the week of June 14 and end around June 26, 2021. There still are many moving parts as the MIAA appears to be allowing teams to opt in or out of the Sectional Tournament and play games on their own. High School coaches are still trying to figure things out but as of today we are shooting for a start date of June 28, 2021 which is one week earlier than originally planned. I have told the Athletic Committee and all Team Managers that the hallmark of 2021 is going to be flexibility.

To this end I have asked all teams to complete the registration process as quickly as possible so that we will be ready to begin play as early as possible. Coaches are undergoing background checks and taking abuse training and teams are purchasing insurance. We are going to hold off completing the 2021 Department Rules until we can get a better handle on what the season will look like.

One final point, we have an opening on the Athletic Committee for an Assistant Umpire in Chief. I would like to ask the Commander to appoint Mark D'Angelo of Franklin to fill that vacancy. Mark is well known to me and I highly recommend him for this position.
