Treasurer

TRS Souza reported: This Financial report is as of 11/24/2021.

Budget and Finance Committee

With our approved budget of \$613,749.00 for this fiscal year, we had total expenses of \$583,840.00 to date.

Overall expenses have been normal with no abnormal expenditures to report. The Treasurer and our in-house Accountant have met to insure a seamless approach to our finances. This will occur regularly.

Our committee reviewed our current day to day budget, our investments and our current budget versus our upcoming year 2022-2023 fiscal budget. As we discussed, all program committees need to review their current budget and the upcoming budget to operate for the next fiscal year. Any changes should be brought forward for discussion and approval for next year, as we are beginning to plan for the future.

Investments

Total investments, as of 11.24.2021 are at \$4,513,188.93 up from previously reported at the last DEC meeting in September. A gain of \$55,270.91 was reported as the market continues to fluctuate. As our growth continues, once again, we must keep in mind, many of these investments are “restricted in nature” and should not be thought of as funds that can be accessed for any reason. These funds are closely monitored by our Legion Investment Committee.

RBC Capital Wealth Management has \$3,326,492.04

Boston Harbor Wealth Advisors has \$1,241,967.80

Unclaimed Property

Continues to be active as we have had some post who feels they might have additional funds coming. That is being looked at by the Inspector at the Unclaimed Funds Division of the Commonwealth's Treasurer's Department.

Additionally, it appeared that there were some larger investments (\$20,000.00 or more) that were not forwarded to our Department. That is being reviewed by the Treasurer's office and hope to have a clarification soon.

We have also requested to find any additional unclaimed funds that might pop up from time to time.

What typically happen, are financial institutions reports unclaimed funds to the Commonwealth on a regular basis. Your treasurer has requested these funds, from the American legion, be reported to us.

Audit

Our current audit is one in progress as has been delayed due to the closure of the Statehouse!

Membership

DSVC Nay reported:

Currently Massachusetts is in 26th place nationally and we just made the last goal of 65%. In the Eastern region this places us 10th out of 13.

19% of our posts have fewer than 60% membership paid for 2022.

The department is now able to run a report for the paid Post 462/ DMS members and a copy of the report was sent out several weeks ago. To date only 154 transfers have been made. We are significantly behind last year. When reviewing the report there are over 2000 paid members to contact. I hope that we now make a move to contact and transfer those members to a local post. I and the other vice-commanders are here to assist. If your district would like we can arrange revitalization on a department level only or we can discuss with the Department Adjutant having national come in if possible.

Department Chairman Finance Committee

The Finance Committee met this morning at the Best Western Royal Plaza Hotel in Marlboro MA. We performed a review of the current budget and a look ahead at the 2022-2023 Budget. Update to the budget for the increase cost of the commander jewel was approved. Motion was made seconded and approved to increase Salary Accounts by 3% for the 2022-2023 Budget.

The Chair of the Boys Scout Committee John O'Connor addressed the committee with a review of their needs. The committee approved funding the Teixeira Leadership Award at \$500.00.

The committee approved a request from the Oratorical Committee for a one time increase of \$580.00 to pay for the Challenge Coins for contestant in the Department Final.

Discussion was held on health care cost for the Department Membership Coordinator. The Department provides health insurance for Full Time Employees only. Although the position is part time, the incumbent is working additional hours to fill in for the vacant Administrative Assistant, thereby working full time hours. The Adjutant was directed to fill the Administrative Assistant position. To compensate the Membership Coordinator for last year it was moved to pay up to 80% of her health care cost not to exceed \$1600.00 from the Administrative Assistant Account, to reimburse the Membership Coordinator for her Health Insurance.
